



2. Install Wireless Drivers


 Turn off your computer, unplug the power cable then remove the case panel.



Connect the provided F USB Cable (Bluetooth USB cable) to the adapter.




3. Locate an available PCle x1 slot and carefully insert the adapter.




 Locate an available F_USB connector and carefully plug the Bluetooth USB cable into it.

<u>Note</u>: If the Bluetooth USB cable is not correctly connected to the motherboard, the Bluetooth function won't work even after driver installtion.




5. Connect the antennas to the adapter.



<u>Note</u>: To maximize performance, avoid physical obstructions in the path between your antennas and router.

- Put your case panel back on, plug in the power cable and turn on your computer.
- After connecting your adapter to the computer, you will need to install the wireless and Bluetooth drivers separately. You would need to restart the computer after each driver installation
